COMES NOW Petitioner CYNTHIA WARD and alleges as follows:

INTRODUCTION

- 1. This action is brought pursuant to Elections Code sections 13103, 13104, 13107, 13307, 13313, and 13314 to correct a false, misleading, and unlawful statement of a candidate's name and to correct a false, misleading, and unlawful ballot designation.
- 2. Real Party in Interest Steven Lodge ("Lodge") is a candidate for the Anaheim City Council in the November 6, 2012, election. Elections Code section 13103 requires inclusion of the names of qualified candidates. Lodge has requested that his name appear on the ballot as "Steve Chavez Lodge." On information and belief, this is not his legal name. Nor is that the name under which he is registered to vote or the name under which he owns property. Rather, the use of the middle name "Chavez" appears to have been adopted recently for political purposes.
- 3. Lodge's selected name to appear on the ballot violates the Elections Code and should be struck from the ballot materials.
- 4. Pursuant to California Elections Code section 13107, Lodge is entitled to choose a ballot designation to appear immediately under his name on the ballot. The Elections Code provides that a candidate like Lodge may choose a ballot designation of no more than three words describing his current principal professions, vocations, or occupations.
- 5. Lodge's chosen designation as "Retired Policeman/Businessman" violates the Elections Code. Lodge does not meet the requirements set forth in Elections Code section 13107, subdivision (b), and in Title 2 of the California Code of Regulations, section 20716, subdivision (h), to designate himself as a "Retired Policeman." That designation must be struck from the ballot materials.
- 6. Petitioner Cynthia Ward, an elector of the city of Anaheim, therefore seeks by this action to compel Respondent Neal Kelley, the Orange County Registrar of Voters, and Respondent Linda Andal, the clerk of the city of Anaheim, to require use of Lodge's legal name and to reject candidate Lodge's false and misleading ballot designation.

PARTIES

- 7. Petitioner CYNTHIA WARD is a resident, taxpayer, and qualified, registered elector of the city of Anaheim.
- 8. Respondent NEAL KELLEY is the Orange County Registrar and is sued herein in his official capacity. Among Respondent Kelley's duties and responsibilities as the Orange County Registrar are the duties to issue, accept, and certify candidates nomination documents for the November 6, 2012, Anaheim City Council election, and to ensure the accuracy and lawfulness of the ballot designations chosen by those candidates, and to reject any ballot information or designations that violate the restrictions contained in Elections Code sections 13103, 13104, 13107, and 13307. Respondent Kelley's duties also include preparing and printing the ballots, sample ballots, and other official matters in connection with that election.
- 9. Respondent LINDA ANDAL is the City Clerk of the City of Anaheim and is sued herein in her official capacity. Among Respondent Andal's duties and responsibilities are the duties to issue and accept candidates' nomination documents for the November 6, 2012, Anaheim City Council election. Respondent Andal, in her official capacity, has "charge of all City elections." (Charter of the City of Anaheim, section 704, subdivision (h).)
- 10. Petitioner is unaware of the true names and capacities of Respondents DOES 1 through 10, inclusive. Petitioner is informed and believes, and thereupon alleges, that each of Respondents Does 1 through 10 is responsible in some manner for the events and happenings referred to in this Petition and is therefore liable for the acts and activities alleged herein. Petitioner will seek leave of Court to amend this Petition to set forth the true names and capacities of these respondents when the same have been ascertained.
- 11. Real Party in Interest STEVEN LODGE is a candidate for Member of the Anaheim City Council at the November 6, 2012, election. Lodge is the candidate who chose the candidate name and ballot designation that are challenged in this action.

12. This Verified Petition is brought pursuant to California Code of Civil Procedure section 1085 and California Elections Code sections 13313 and 13314, in that an error or omission and neglect of duty have occurred and are about to occur in Respondents' acceptance of Real Party Lodge's false, misleading, and unlawful candidate name and ballot designation and in the imminent printing of such unlawful information in the ballot materials for the November 6, 2012, election. Venue is proper in Orange County because Respondent resides in and is located in Orange County, and because Real Party in Interest Lodge will appear on the ballot for election to the City Council of Anaheim within Orange County.

GENERAL ALLEGATIONS

- A. Lodge's False, Misleading, and Illegal Use of the Name "Steve Chavez Lodge"
- 13. Pursuant to Elections Code section 13103, every ballot shall contain the names of all qualified candidates. (Elec. Code, § 13103, subd. (b).) If a candidate changes his or her name within one year of any election, "the new name shall *not* appear upon the ballot." (Elec. Code, § 13104 (emphasis added).) The only exception to the name change provision is where the name change occurred as a result of marriage or by judicial decree. (Elec. Code, § 13104, subds. (a) & (b).)
- 14. In violation of these laws, Lodge has demanded that his name appear on the ballot as "Steve Chavez Lodge." (A true and correct copy of Lodge's Ballot Name, Ballot Designation, and Candidate Statement is attached to this Verified Petition as Exhibit A.)
- 15. On information and belief, Lodge's legal name is not "Steve Chavez Lodge."
- 16. Rather, according to a background check, Lodge is known as "Steven A Lodge" or "Steven Albert Lodge." (A true a correct copy of that background check is attached to this Verified Petition as Exhibit B.)
 - 17. The background report on Lodge states that Lodge is the co-owner of a

property at 8616 Canyon Vista Dr., Anaheim, CA 92808, and that Lodge owns the property under the name "Steven A Lodge." (See Exhibit B.) This is the same address at which Lodge is registered to vote. (A true and correct copy of a screen print out of Lodge's voter registration record is attached to this Verified Petition as Exhibit C.)

- 18. The background report also identifies "Tonya L Compton" as a co-owner of the 8616 Canyon Vista Dr. property. (See Exhibit B.) On Lodge's campaign website (www.stevelodgeforanaheim.com), he refers to his wife "Tonya," in the "About Steve" section. (A true and correct copy of a screen print out of the "About Steve" section of Lodge's website is attached to this Verified Petition as Exhibit D.)
- 19. Lodge is also registered to vote as "Steven Lodge," with no mention of the name "Chavez." (See Exhibit C.) The Elections Code requires a voter to register to vote using the "affiant's name at length, including his or her given name, and a middle name or initial, or if the initial of the given name is customarily used, then the initial and middle name." (Elec. Code, § 2150, subd. (a)(2).) Registration to vote in the district in which a candidate seeks election is a requirement for candidacy. (See Gov. Code, § 36502 subd. (a).) By registering to vote as "Steven Lodge," Lodge confirmed that his true and complete name is "Steven Lodge."
- 20. Lodge has previously identified himself on official documents filed in connection with his candidacy for Anaheim City Council as "Steve Lodge." Lodge's Form 501 Candidate Intention Statement was submitted to Respondent Andal in October 2011 under the name as "Steve Lodge." Lodge signed that document as "Steve Lodge." (A true and correct copy of Lodge's Candidate Intention Statement is attached hereto as Exhibit E.)
- 21. In October 2011, Lodge also submitted to Respondent Andal a Form 410, Statement of Organization, for the "Lodge for City Council 2012" committee. That document asks candidates to list the "name of officeholder or candidate." Lodge filled in "Steve Lodge" and signed his name as "Steve Lodge." (A true and correct copy of the campaign's Statement of Organization is attached hereto as Exhibit F.)

- Lodge." For instance, in 2002, Lodge made three separate contributions to the Santa Ana Police Officers Political Action Committee totaling \$50.00 under the name "Steven Lodge." (A true and correct copy of a "Contributor Report" for Steven Lodge from the California Secretary of State's website, accessed on August 17, 2012, is attached to this Verified Petition as Exhibit G.)
- 23. In 2006 and 2007, Lodge made four contributions totaling \$173.16 to the Santa Ana Police Officers Association Independent Expenditure Committee under the name "Steven Lodge." (A true and correct copy of a "Contributor Report" for Steven Lodge from the California Secretary of State's website, accessed on August 17, 2012, is attached to this Verified Petition as Exhibit H.)
- 24. On May 19, 2010, Lodge donated money to the Committee to Re-Elect Loretta Sanchez under the name "Steven Lodge." (A true and copy of a Contribution Report for Steven Lodge from the Federal Election Commission's website, accessed on August 17, 2012, is attached to this Verified Petition as Exhibit I.)
- 25. Accordingly, Lodge's proposed use of the name "Steve Chavez Lodge" on the ballot is false and misleading. His name must be amended to appear before the voters as "Steven Lodge," the name under which he registered to vote and filed his Candidate Intention Statement.

B. Lodge's Illegal Ballot Designation

- 26. Pursuant to Elections Code section 13107, candidates for elective office may choose one of four possible types of ballot designations. (Elec. Code, § 13107, subd. (a).) Section 13107, subdivision (a) provides in pertinent part:
 - "(a) With the exception of candidates for Justice of the State Supreme Court or Court of Appeal, immediately under the name of each candidate, and not separated from the name by any line, unless the designation made by the candidate pursuant to Section 8002.5 must be listed immediately below the name of the candidate pursuant to Section 13105, and in that case immediately under the designation, may appear at the option of the candidate only one of the following designations:

- "(1) Words designating the elective city, county, district, state, or federal office which the candidate holds at the time of filing the nomination documents to which he or she was elected by vote of the people, or to which he or she was appointed, in the case of a superior court judge.
- "(2) The word "incumbent" if the candidate is a candidate for the same office which he or she holds at the time of filing the nomination papers, and was elected to that office by a vote of the people, or, in the case of a superior court judge, was appointed to that office.
- "(3) No more than three words designating either the current principal professions, vocations, or occupations of the candidate, or the principal professions, vocations, or occupations of the candidate during the calendar year immediately preceding the filing of nomination documents. For purposes of this section, all California geographical names shall be considered to be one word. Hyphenated words that appear in any generally available standard reference dictionary, published in the United States at any time within the 10 calendar years immediately preceding the election for which the words are counted, shall be considered as one word. Each part of all other hyphenated words shall be counted as a separate word.
- "(4) The phrase "appointed incumbent" if the candidate holds an office other than a judicial office by virtue of appointment, and the candidate is a candidate for election to the same office, or, if the candidate is a candidate for election to the same office or to some other office, the word "appointed" and the title of the office. . . " (Elec. Code, § 13107, subd. (a) (emphasis added).)
- 27. Because Lodge currently holds no elective office and is not an incumbent or appointed incumbent for the office he is seeking, his only option is to proceed under Elections Code section 13107, subdivision (a)(3), and to provide no more than three words designating his "current principal professions, vocations, or occupations."
- 28. Underscoring the requirement that a ballot designation be the candidate's "current" principal professions, vocations, or occupations, the Elections Code prohibits ballot designations that use words or prefixes, such as "former" or "ex-," which indicate prior status. (Elec. Code., § 13107, subd. (b)(4).)
- 29. Only in limited circumstances may a candidate use the word "retired" in a ballot designation. For instance, a "candidate may not use the word 'retired' in his or her ballot designation if that candidate possesses a more recent, intervening principal profession, vocation, or occupation." (Cal. Code Regs., § 20716, subd. (h)(4).)

- 30. In contravention of these clear restrictions, Lodge has selected as his ballot designation "Retired Policeman/Businessman." (See Exhibit A.)
- 31. In doing so, Lodge is at once claiming that he is a "Retired Policeman" who does not "possess a more recent, intervening principal profession, vocation, or occupation" (Cal Code Regs., § 20716, subd. (h)(4)) and that his "current principal profession, vocation, or occupation" (Elec. Code § 13107, subd. (a)(3)) is a "Businessman."
- 32. Lodge cannot legally use the ballot designation "Retired Policeman" because, by his own admission, after retiring as a police officer, he acquired "another more recent, intervening principal profession, vocation, or occupation" (Cal Code Regs., § 20716, subd. (h)(4)) that of a "Businessman."
- 33. In addition to his ballot designation claiming to be a "Businessman," his candidate statement asserts that "[s]ince retiring from the police force I have worked for a large construction management firm." (See Exhibit A.)
- 34. Lodge's campaign website also boasts that "[a]fter 30 years of public service, I joined an international construction management firm as Director of Public Affairs." (See Exhibit D.)
- 35. Earlier this month, in August 2012, Lodge filed with the Fair Political Practices Commission a Form 700 Statement of Economic Interests in which he reported income for calendar year 2011 between \$10,000 and \$100,000 from Hill International, Inc., a construction management firm. Lodge further disclosed in that submission that he holds the position of Director of Public Affairs at that company. (A true and correct copy of Lodge's Form 700 is attached to this Verified Petition as Exhibit J.)
- 36. Inclusion of "Retired Policeman" in Lodge's ballot designation is therefore unlawful and must be struck from the ballot.
- 37. In addition to the prohibition of the use of the word "retired" when, as is the case here, a "candidate possesses a more recent, intervening principal profession,

- § 13107, subds. (b)(1) & (c); see also 2 Cal. Code Regs., § 20716, subd. (a).)
- Petitioner is informed and believes, and on that basis alleges, that Lodge did 43. not meet his burden of establishing the accuracy and lawfulness of his proposed ballot designation.
- Petitioner has no plain, speedy and adequate remedy in the ordinary course 44. of law, in that no damages or other legal remedy could compensate for the harm that she and the other electors of Anaheim would suffer if Lodge's inaccurate, misleading and unlawful proposed name and ballot designation were to appear on the ballot materials. Petitioner, who is a resident, taxpayer, and qualified elector of the City of Anaheim, has a direct and beneficial interest in the action herein and brings this action as a private attorney general pursuant to Code of Civil Procedure section 1021.5 to vindicate her own interests and those of the electors of Anaheim in the proper implementation of the provisions of the California Elections Code.

FIRST CAUSE OF ACTION

Code of Civil Procedure § 1085; Elections Code §§ 13103 and 13314 (Writ of Mandate)

- Petitioner realleges and hereby incorporates by reference each and every 45. allegation contained in paragraphs 1 through 44, above.
- Respondents Orange County Registrar Neal Kelley and Anaheim City Clerk 46. Linda Andal have a clear, present, and ministerial duty to reject Real Party in Interest Lodge's unsupported, inaccurate, misleading, and illegal proposed name of "Steve Chavez Lodge" and not to print that name on the ballots, sample ballots, and other official matter for the November 6, 2012, election.
- If not otherwise directed by the Court's issuance of the requested writ of 47. mandate, Respondents Orange County Registrar Neal Kelley and Anaheim City Clerk Linda Andal will accept Real Party in Interest Lodge's unsupported, inaccurate, misleading, and illegal proposed name of "Steve Chavez Lodge" and will print it on the

ballots, sample ballots, and other official matter for the November 6, 2012, election, thereby depriving Petitioner and the electors of the City of Anaheim of their right to an accurate ballot and a fair election. The issuance of the requested writ of mandate will not substantially interfere with the conduct of the election.

SECOND CAUSE OF ACTION

Code Civ. Proc., § 1085; Elec. Code, §§ 13107, 13314 (Writ of Mandate)

- 48. Petitioner realleges and hereby incorporates by reference each and every allegation contained in paragraphs 1 through 47, above.
- 49. Respondents Orange County Registrar Neal Kelley and Anaheim City Clerk Linda Andal have a clear, present, and ministerial duty to reject Real Party in Interest Lodge's unsupported, inaccurate, misleading and illegal proposed ballot designation as "Retired Policeman/Businessman" and not to print that designation on the ballots, sample ballots, and other official matter for the November 6, 2012, election.
- 50. If not otherwise directed by the Court's issuance of the requested writ of mandate, Respondents Orange County Registrar Neal Kelley and Anaheim City Clerk Linda Andal will accept Real Party in Interest Lodge's unsupported, inaccurate, misleading, and illegal proposed ballot designation of "Retired Policeman/Businessman" and will print it on the ballots, sample ballots, and other official matter for the November 6, 2012, election, thereby depriving Petitioner and the electors of the City of Anaheim of their right to an accurate ballot and a fair election. The issuance of the requested writ of mandate will not substantially interfere with the conduct of the election.

PRAYER FOR RELIEF

WHEREFORE, Petitioner prays for judgment as follows:

1. On the First Cause of Action, that this Court issues its alternative and peremptory writs of mandate commanding Respondents Kelley and Andal to reject Real Party in Interest Lodge's proposed candidate name of "Steve Chavez Lodge," to amend
