Another Momentous Year at the Supreme Court

Friday, Sept. 5, 2:45 pm (doors open at 2:00), Clubhouse 5

Those at prior Chemerinsky talks know he's frank, brilliant, yet clear for non-lawyers, and with warm down-to-earth wit. Don't miss him!

Erwin Chemerinsky, a leading scholar, teacher of judges as well as students, litigator in the Supreme Court and



other courts, and constitutional law expert, often analyzes its cases and trends in print and on the air. Author of 6 books and over 100 articles for scholars and law students, many for lay readers too, at his talk here in 2011 he signed for over 100 of us his new "The Conservative Assault on the Constitution."

He often testifies to legislative committees, including Senate hearings to confirm now-Justice Samuel Alito. His amazingly prolific public service includes chairing the L.A. City Charter Reform Commission. A Harvard Law School graduate, he taught law at USC for 21 years, then Duke, and moved to Irvine in 2008 to found UCI Law School. Can you explain how some Supreme Court cases impact more people than even most Congressional laws? How appointments change its precedents? Or, thus, how elections turn the Court's direction?

Its 2013-14 term was indeed "momentous". Its 5 conservatives held that: A for-profit family-owned corporation has "religious free exercise" rights; the campaign finance reform law's total limits violate the First Amendment; Christian-only prayer at a town's council meetings is constitutional; and home caregivers can not only refuse to join the union that represents them, but also refuse to pay for that union's regular bargaining and grievance services.

Dean Chemerinsky will analyze those and lower profile rulings that'll impact even more lives, and that extended trends he explained in prior talks: Procorporation, pro-business, limiting rights of consumers and workers, defining police power to search versus privacy, new technology, etc.

DIRECTIONS to Clubhouse 5 – 24262 Punta Alta, Laguna Woods, CA 92637 – via Gates 9 or 10

From 405 or 5 Fwy Southbound (or Lake Forest Drive at 5 fwy, or Irvine Center Dr. at Lake Forest Dr.):

- Exit at Lake Forest Dr. (exit #1B off the 405, #92 off the 5); on long exit ramp, stay right to avoid return to fwy
- At exit ramp stoplight, right turn onto Lake Forest Drive westbound
- 0.3 mile on Lake Forest Drive westbound, to left turn at Moulton Parkway southbound
- (• Moulton Pkwy is the 2nd street; to right it's "Irvine Center Dr."; <u>don't take that</u>; do turn left onto Moulton)
- 0.9 mi. on Moulton southbound, to right turn at Santa Maria Ave. (next light after major street Ridge Route)
- 0.9 mi. on Santa Maria westbound, to left at 2nd stop sign/"Gate 10/ Avenida Sosiega" sign (near deadend)
- Left in Gate 10; show Gate Entry Slip (below); if asked, turn it in. Straight on Avd. Sosiega
- 0.6 mi. on Sosiega, to right turn at Monte Hermoso (3rd right, a stop sign). 0.2 mi. up hill to 1st right, Punta Alta
- 100 ft. on Punta Alta to 1st right into huge lot. Park. CH 5 entrance is obvious. Walk 50 yds to Main Room

From 5 Fwy Northbound (or El Toro at the 5 fwy, or Moulton at El Toro):

- Exit at El Toro Road. At exit ramp stoplight, turn left onto El Toro, go under freeway
- 1.0 mile on El Toro westbound, to right turn at Moulton Pkwy northbound (6th light, pass Valencia, Sevilla, etc.)
- 0.7 mi. on Moulton northbound to left turn at Santa Maria Avenue westbound (2nd light)
- Go to and follow from 6th bullet ("0.9 mi. on Santa Maria") of section above ("From 405 or 5 Fwy South...")

From 73 Tollroad at El Toro Road (or Laguna Canyon to El Toro to the 73):

- Exit at El Toro, turn onto El Toro north-east toward Laguna Woods
- 0.9 mile on El Toro, to 2nd light at "Calle Corte / Gate 9" (after passing Aliso Creek Road); left into Gate 9
- At gate show Gate Entry Slip (below). If asked, turn it in
- 0.1 mi. to Sosiega (deadend); right on Sosiega 0.2 mi. to Monte Hermoso (1st stop sign)
- Left on Monte Hermoso, up hill 0.2 mi. to 1st right, Punta Alta. Right turn, 50 yds on Punta Alta
- Immediate right into huge lot. Park. Clubhouse 5 entrance is obvious. Walk straight 50 yds to Main Room
