SUBJECT: Request by Blenheim Facility Management for Use of Reata Park

for Riding Park Equestrian Activity Parking and Waiver of Rental

Fees.

RECOMMENDATION:

Approve request from Blenheim Facility Management for intermittent vehicle and trailer parking at Reata Park in support of equestrian events at the Rancho Mission Viejo Riding Park at San Juan Capistrano, and waive associated park rental fee.

DISCUSSION/ANALYSIS:

The City-owned Riding Park is located in the area known as the Eastern Open Space, at the southwest corner of Ortega Highway and Avenida La Pata (Attachment 1). The Eastern Open Space was purchased from the Rancho Mission Viejo Company in 2010. The Riding Park hosts equestrian events, soccer tournaments, and other sporting and community events. On February 2, 2021, the City Council approved the Second Amendment to the 2018 Riding Park Management Agreement to allow BFM to host equestrian events and other permitted activities during the 2021 season (Attachment 2). The agreement allows the 2021 equestrian show season to proceed as planned, as long as events are in compliance with all regulations and health guidelines associated with the COVID-19 pandemic. BFM successfully operated a limited show season in 2020 in compliance with public health guidelines.

Recent implementation of interim water quality measures at the Riding Park has reduced the overall area available for hosting large equestrian events. To accommodate the larger equestrian shows, BFM has requested limited use of a portion of Reata Park for parking of empty horse trailers and other vehicles related to the events. Due to its off-site location, BFM has indicated the parking areas at Reata Park would only be used if they cannot accommodate activities on-site and may not be necessary for each planned event. The

areas of Reata Park requested include underutilized parking areas, the area around the monument/U.S. flag, and open areas beyond the paddocks. If approved, BFM would use Reata Park for overflow parking intermittently from March through September 2021, for a maximum total of approximately 90 days. BFM parking would be modified or discontinued should it interfere with events planned for Reata Park. Access and security would be coordinated between City and BFM staff for the duration of any park use. Historically, the successful operation of an equestrian show season at the Riding Park brings participants, spectators, and show workers to the community and generates secondary financial benefits for San Juan Capistrano businesses such as restaurants, retail stores and hotels.

Typically, park rentals are subject to an hourly charge that varies depending on the size and type of activity. As required by the Management Agreement, BFM pays the City a management fee of \$20,000 per month for their use of the Riding Park to host various events, and staff recommends that the use of Reata Park for parking in support of show related activities be approved with no additional charge to BFM.

FISCAL IMPACT:

Approval of the recommended action would waive the park rental fee for exclusive use of limited portions of Reata Park. BFM remits to the City monthly revenue payments of \$20,000 for the events hosted at the Riding Park. Consistent with past practice, this revenue is appropriated to pay for the maintenance and operating expenditures of the entire Eastern Open Space area.

ENVIRONMENTAL REVIEW:

In accordance with the California Environmental Quality Act (CEQA), the recommended action is exempt from CEQA per Section 15061(b)(3), the general rule that the CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. The use of an existing park facility and seeking a full fee waiver for facility rental fee is not an activity with potential to cause significant effect on the environment and therefore exempt from CEQA.

SECOND AMENDMENT TO RIDING PARK MANAGEMENT AGREEMENT

THIS SECOND AMENDMENT TO RIDING PARK MANAGEMENT AGREEMENT (the "<u>Amendment</u>") is made by and between the City of San Juan Capistrano, a municipal corporation ("City") and Blenheim Facility Management, LLC, a Delaware limited liability company ("Company") as of February 2, 2021, with respect to the following facts:

- A. City and Company are parties to that certain Riding Park Management Agreement dated as of January 1, 2018 ("**Agreement**") for the operation, management and maintenance of the Rancho Mission Viejo Riding Park.
- B. City and Company are parties to The First Amendment to Riding Park Management Agreement dated July 2, 2019 ("**First Amendment**").
- C. The First Amendment expired on December 31, 2019 and renewed on a month to month basis thereafter. The Parties now desire to extend the term of the Agreement.

IN CONSIDERATION OF THE FOREGOING, the parties agree as follows.

- 1. **Effective Date; Term**. Paragraph 1.1 of the Agreement is deleted in its entirety and restated as follows:
 - "Effective Date; Term. This Agreement shall be effective on February 2, 2021 (the "Effective Date"), but the term of Company's management of the Riding Park Parcel pursuant to this Agreement shall be the "Management Term" set forth in Section 1.2. This Agreement shall terminate and be of no further force or effect as of 11:59 p.m. on December 31, 2021. At the City's sole discretion, this Agreement may be extended for an additional twelve months, through December 31, 2022, unless sooner terminated pursuant to the terms of this Agreement ("Termination Date")."
- 2. <u>Exhibit C.</u> In recognition of scheduling constraints due to the COVID-19 pandemic, a typical annual schedule of events is included as Exhibit C. Should similar events be scheduled through the course of the agreement term, Company shall not be required to remit Gross Revenue Fee to the City. The Gross Revenue Fee shall only apply to events not typically held at the facility and remitted to the City as set forth in Section 2.1.13.
- 3. <u>Affirmation</u>. Except as otherwise provided in the First Amendment and in this Second Amendment, the terms and conditions of the Agreement are hereby ratified and confirmed and shall remain in full force and effect.
- 4. <u>Necessary Acts.</u> Each Party shall perform any further acts and execute and deliver any further documents that may be reasonably necessary to carry out the provisions of this Amendment.
- 5. <u>Entire Agreement; Amendments</u>. This Amendment is the entire agreement between the Parties concerning the subject matter hereof, and supersedes any prior negotiations, discussions, oral or written communications, or agreements between the Parties. The terms of

this Amendment may only be modified or amended by an instrument in writing executed by all Parties.

6. <u>Reservation of Rights</u>. Notwithstanding anything in this Amendment to the contrary, all claims and contentions of City and Company as set forth in the pleadings on file in the pending case of *City of San Juan Capistrano v. Tokio Marine Specialty Insurance Company and Blenheim Facility Management, <i>LLC* filed in the Superior Court of the State of California, County of Orange as Case No. 30-2019-01061811-CU-IC-CJC are reserved.
